In order for a student to succeed at Global College, the student must agree and abide to the Global College Culture, as outlined below:



English Only Policy

- Global College has a very strict English Only Policy. When you arrive at the front doors of the building, you may no longer speak your native language. GC staff members always have their ears open for people who are ignoring this rule.
- You may not speak your native language in these areas: lobby, elevator, classroom during lunch and breaks.
- If you get 3 warnings from either teaching or office staffs, you will be asked to leave the classroom for one session.
- If you get 6 warnings, you will be asked to leave your classroom for one week, and there will be no tuition refund.
- *This rule applies for when students are off-campus. Including but not limited to outside the building and activities/excursions.*

Cell phone rule

- No cell phone usage is allowed in classroom.
- Please keep your phone in a silent mode for other classmates.
- If the phone is used, it must be in English for when on school grounds or during program hours.

Non-Academic Misconduct

- Global College reserves the right to suspend or dismiss any student for non-academic misconduct or violation of the student code of conduct, which includes, but is not limited to, the following:
 - *Behavior that is generally considered to threaten or cause harm or injury to a person.*
 - *Behavior that is generally considered to threaten or cause damage to Global College's Property or the property of others.*
 - *Conduct that disrupts the educational activities, services, or events provided by Global College for students or members of the community.*
 - *Discrimination or harassment of others.*
 - *Behavior or conduct that is otherwise unlawful.*

Attendance/Late policy

- a) You are recorded as late if you walk in 15 minutes after the class starts.
- b) It is your teacher's decision if you can enter the classroom after 15 minutes.
- c) If you are late twice, it counts as one absence.
- d) You are required to attend all the classes regularly and on time.
- e) Students are required to have 85% of attendance in their overall program for successful completion.

PARENTAL CONSENT

I the parent or legal guardian of this Participant hereby grant my permission for the Participant to participate fully in children/youth English programs and child care, including trips away from the school premises. Furthermore, I, on behalf of my minor Participant, hereby assume all risk of accidental personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved therein. The undersigned further hereby agrees to hold harmless and indemnify said Team for any liability sustained by said Team as the result of the negligent, willful or intentional acts of said Participant, including expenses incurred attendant thereto.

MEDICAL TREATMENT PERMISSION: I authorize an adult, in whose care the minor has been entrusted, to consent to any emergency x-ray examination, anesthetic, medical, surgical or dental diagnosis or treatment and hospital care, to be rendered to the minor under the general or special supervision and on the advice of any physician or dentist licensed under the provisions of the Medical Practice Act on the medical staff of a licensed hospital or emergency care facility. The undersigned shall be liable and agrees to pay all costs and expenses incurred in connection with such medical and dental services rendered to the aforementioned child or youth pursuant to this authorization.

EARLY RETURN HOME POLICY: Should it be necessary for my child or youth to return home due to medical reasons, disciplinary action or otherwise, the undersigned shall assume all transportation costs and responsibility.

TRANSPORTATION PERMISSION: The undersigned does also hereby give permission for my child/youth to ride in any vehicle driven by an approved and licensed ADULT chaperone while attending and participating in activities sponsored by Global College. My child/youth and I understand that SEAT BELTS MUST BE WORN AT ALL TIMES (when applicable by law) during transportation.

INSURANCE: The undersigned agree to provide MANDATORY Travelers Insurance for the Participant along with a copy of said insurance for Global College's records.
